### Release Waiver Liability & Indemnity

I hereby understand and agree to the following:

In consideration of being permitted to participate in classes, trainings, workshops, programs or other services offered, I agree to assume full responsibility for any risks, injuries, damage known or unknown, which I might incur as a result of participating.
2. It is my responsibility to consult with a physician prior to and regarding my participation in this yoga class. I represent and warrant that I am physically fit and have no medical condition that would prevent my participation in the yoga class, workshop, teacher training or any other service being offered.
3. Instructors may provide adjustments, and it is my responsibility to inform the adjustor prior to class if I do not want any such physical adjustment. It is also my responsibility to inform the adjustor when an adjustment has gone as far as I desire at that time.
4. I understand that I am responsible for bringing my own equipment to classes, but I am permitted to use the equipment provided at my own risk.

I release and discharge 1681247 Alberta Ltd. operating as Yogadown, its owners, directors, instructors, adjustors, contractors, staff and volunteers from any liability, claim, demand or action that I may have resulting from injury, death or damages arising from my participation in class, workshop or program or at that yoga studio, including loss that may be caused by negligence of the released party. If your cancel your reservation prior to 7 days before the class's commencement: 15% of payment is charged for an administration fee and the balance of your payment will be available as a credit on your account. **KEY FOBS:** I agree that once I have received a Yogadown Scan Key Fob that I will not share it with others and in the event I have lost they key fob I agree to pay \$5 to get a replacement. **LATE ENTRY:** Late entry is not permitted to class. Yogadown has the right to change and revise these policies at any time.
