Release Waiver Liability & Indemnity

Understand agree to the following:

1. The information about the Child provided herein is true and correct and have full legal rights to enroll my child in a yoga class at Yogadown.
2. I recognize that yoga requires physical exertion, which may be strenuous and may cause physical injury, and I am fully aware of the risks and hazards involved by enrolling my child in a yoga program.
3. It is my responsibility to consult with a physician prior to and regarding my child's participation in this yoga class. I represent and warrant that my child is physically fit and have no medical condition that would prevent their participation in the yoga class/ workshop.
4. In consideration of being permitted to participate in the yoga class, I agree to assume full responsibility for any risks, injuries, damage known or unknown, which my child might incur as a result of participating in the program.
5. That I am responsible for bringing yoga equipment to class for my child, but my child is permitted to use the equipment supplied by Yogadown provided at my and my child's and my own risk.
6. I release and discharge Yogadown, its directors, and the Yogadown instructors, adjusters, staff and volunteers from any and all liability, claim, demand or action that my child or I may have resulting from injury, death or damages arising from my participation in the yoga class/workshop or at that yoga studio, including loss that may be caused by the negligence of the released party. This includes participation in classes/workshops held away from the Yogadown premises.
7. I release and discharge Yogadown, its directors and its instructors, adjusters, staff and volunteers from any and all liability, claim, demand or action that my child or I may have related to the loss, theft or damage of any of my personal property from the Yogadown premises.
8. All class passes and memberships are non-refundable, non-transferrable and may not be suspended at any time for any reason, including, but not limited to vacation, illness and injury.
9. I agree that once my child or I receive a Yogadown Key Fob that I will not share it with others. In the event I have lost my key fob I agree to pay \$5+gst to get a replacement.
10. I recognize that this agreement of release and waiver of liability is a legal contract and that, by reading it carefully, I have complete knowledge of its contents.
